Information is also provided on the new statutory requirements for continuing professional development and the new law requiring therapist disclosure of certain professional information that DORA will use to create each therapist's profile for the public. Also new this year are a revised Client Disclosure Statement and a new Clinical Supervision Contract. And numerous statutory citations have been updated throughout the book.
